### **EQUIPMENT:**

Equipment and systems covered by this certificate are as follows:

There are three different materials of the enclosure of the product, SD-125 (stainless steel), SD-135 (aluminum alloy), SD-150 (GRP). The product is made up of; Main body, back-cover and front-cover, connected together by a spigot joint. Furthermore the product has a sounder driver which is screwed into the frontcover by an Ex thread. A sintered disc is press fitted into a slot of this and kept in place by a press fitted ring. In addition a horn arrangement is attached to the front cover.

Type Designations:

Type SD-125/135/150-1with an build in amplifier PCB, function as an alarm sounder.

Type SD-125/135/150-2 with or without a build in audio transformer, function as loudspeaker.

Type SD-125/135/150-3 with build in audio transformer and amplifier PCB, function as sounder/loudspeaker.

There can be four optional sizes of cable entries (M20/M25 or 1/2NPT, 3/4NPT).

### CONDITIONS OF CERTIFICATION: YES as shown below:

Repairs of the flameproof joints must be made in compliance with the structural specifications provided by the manufacturer. Repairs must not be made on the basis of values specified in tables 1 and 2 of EN/IEC 60079-1
